1. Purpose. To announce Funeral Honors Support (FHS) Watch bill assignments for Naval Air Station (NAS) Patuxent River for Fiscal Year 2021.

2. Discussion.

a. Naval District Washington (NDW) FHS Regional Coordinator has designated NAS Patuxent River as a Sub-Area Coordinator. As a Sub-Area Coordinator, NAS Patuxent River serves St. Mary's, Calvert, and Charles counties.

b. The provision of Military Funeral Honors is a total force mission. Watch bill assignments for the NAS Patuxent River are made on a "fair share" basis, and are based on military labor in the paygrades of E-7 through O-4.

c. Funeral honors are rendered per reference (a).

3. Action.

a. Unit FHS Coordinators must provide names, phone numbers (work and mobile) and email addresses of their watch bill personnel to the NAS Patuxent River Command Duty Officer (CDO) at CDO.NPAXR.FCM@Navy.mil at least one week prior to assigned duties.

b. Watch begins at 0700 each Monday. The watchstander must contact the NAS Patuxent River CDO at 301-342-1095 to validate recall information. Watchstanders must be able to report to the CDO within three hours of receiving initial notification of a request for military funeral honors. Funeral honors requests may be received as early as 12 hours prior to the scheduled event, thus all assigned personnel must have their service dress uniform inspection ready during the week assigned.

c. The Funeral Honors team will consist of three members, one CPO or Officer as the Head Bearer, and two members from the NAS Patuxent River Color Guard.

4. Records Management. Records created, as a result of this notice, regardless of media and format, must be managed as per SECNAV Manual 5210.01 of January 2012.
