

We received another FOIA request related to Greenbury Point. This one from (b) (6) of the Washington Post (he appears to be a DMV-focused reporter rather than national). Request is similar, but not identical, to past requests:

"Any and all documents concerning a proposal to build a golf course on the Greenbury Point peninsula located across from the United States Naval Academy between the Severn River and the Chesapeake Bay in Annapolis, Maryland. More specifically, we would like to obtain copies of emails, letters, memoranda, maps, plans, images or any other documentation related to a proposal advanced by (b) (6) who is USNA athletics director and president of the Naval Academy Golf Association, and perhaps others to build a second golf course.

"I would also be grateful if the Navy would provide documents responsive to similar FOIA requests regarding Greenbury Point and its conservation area and proposed golf course."

Keeping in mind that you and your team have already conducted a search regarding Greenbury Point, I request that you provide me with any additional records which have been generated since you completed your last search. I also ask that you and your team review your inbox/sent items for "any and all" emails related to Greenbury Point and the golf course proposal. Any person at NSAA who may reasonably be expected to have e-mails regarding the Greenbury Point golf course proposal should be asked to conduct a search of their inbox/sent items.

I respectfully request a response by 30 September.

To satisfy the second portion of M (b) (6) request, I intend to provide him an interim release consisting of previous FOIA responses on the topic (i.e., all the redacted files that were previously released).

Greenbury Point should be reopened to the public

I live on Martins Cove, which is adjacent to the USNA golf course flowing into Mill Creek. I have been a regular user of Greenbury Point for 25 years. This treasure has served as a recreation spot for thousands of Anne Arundel citizens as well as USNA folks.

The Capital has written about competing interests for this green space, yet there is very little recent news about what will really happen with this land — building a restricted additional 18-hole golf course or keeping this 240-acre land that fronts both the Chesapeake Bay and the mouth of the Severn River

an "open and publicly accessible area."

I am very frustrated with what has recently happened with clear attempts to intimidate users of the area. A chain link fence has been erected around the perimeter and new gates and padlocks have been erected, and access has been significantly restricted for the public.

Adding insult to injury, on a gorgeous fall day, this past Saturday (Nov. 12), I took my bike to enjoy a ride around GP, which I have done for years and it was all locked up.

In past months, the Chesapeake Conservancy has partnered with the Severn River Association and Chesapeake Bay Foundation in opposition to this ill-conceived proposal. Recently, 25 nonprofits signed a joint letter to Navy Secretary Carlos Del Toro in opposition and the two U.S. Maryland senators and two representatives also wrote a letter voicing their concern. There is still bandwidth for concerned citizens to undertake strategic steps to "fight" these egregious punitive actions.

I think the time has come to push to REOPEN GP to the public. ARE WE NOT THE OWNERS OF THIS GREEN FIELD SPACE VIA OUR TAX BASE and the Navy public stewards of this treasure?

l am providing a lot of information primarily more as background information in response to Ms. (b) (6) email as well as the follow-on from (b) (6) (DASN EM&R. Most of this information is intended to be kept "on-hand" should any parties within DOD/Navy request it. Separately below I have provided a draft response to Ms. (b) (6) opening paragraph. I trust that you and the PAO team can and will respond to the rest of her statements, as appropriate.

BACKGROUND

The NSA Annapolis INRMP was developed to support the installation mission by way of compliance with all applicable natural resources laws. This includes compliance with the Sikes Act Improvement Act (SAIA) of 1997, which involved consultation and cooperation with the U.S. Fish and Wildlife Service (USFWS) and the Maryland Department of Natural Resources (MDNR) regarding conservation, protection, and management of fish and wildlife resources, and ongoing annual review of INRMP implementation. The Sikes Act also states that installations, via the INRMP, should provide public access for natural resources uses to the extent it is appropriate and consistent with the installation mission, and that implementation of an INRMP shall not cause any net loss in the capability of the installation to support the military mission.

The objectives and goals of the INRMP focus on responsible stewardship of the natural resources on the installation, with the flexibility necessary to maintain the installation's ability to enable the education, training, and development of midshipmen morally, mentally, and physically. Per the NSA Annapolis INRMP sections regarding Outdoor Recreation, our goal is to provide outdoor recreational opportunities for station personnel, their dependents, and the general public to the maximum extent possible within the constraints of the installation mission and capability of the natural resources. NSA Annapolis restricts access to portions of Greenbury Point when mission activities are taking place that can endanger installation personnel or the public, or is required by mission parameters. It is important to note that several of the outdoor recreation areas, viewpoints, and designated trails, including the Bobwhite Circuit Trail, the Timberdoodle Trail, and the Pipsissewa Trail, remain accessible to the public during the vast majority of mission-related closures at Greenbury Point.



I truly hope you and your team do not make a decision until you have the chance to visit this place.

HISTORY

The Susquehannock Indians inhabited Greenbury Point at the time of European settlement in 1649. By 1676, however, there was virtually no native presence in the area.

The first European settlers on Greenbury Point were given a grant by the proprietary ruler of Maryland: Cecil Calvert, the second Lord Baltimore. The settlement was called Towne Neck and after 1676 the land was principally farmland.

Ralph Williams owned most of Greenbury Point from 1661 until his death in 1673. His heirs owned it until 1685 when it was sold to Nicholas Greenberry, the new namesake of the area.

Most of Greenbury point was purchased by the Naval Academy in

1910 in order to establish a dairy farm. The intent was to provide safe dairy products to midshipmen in a time when tuberculosis was common. In 1914 the dairy farm moved to Gambrills, MD.



Beginning in 1911, the property was used for experimental studies in naval air warfare. From 1918 until 1996 the area was used for communications research and to transmit strategic information to the U.S. fleet in the Atlantic Ocean and the Mediterranean Sea.

All but three of the radio communication towers were dismantled in 1999 and the peninsula is now a managed conservation area. A nature center has been established to promote education, stewardship, and enjoyment of Greenbury Point's rich cultural and natural heritages.

CURRENT MANAGEMENT:

Greenbury Point is managed to support the NSAA mission by enhancing Morale, Welfare, and Recreation uses, protecting environmental conservation and mitigation measures, and accommodating compatible mission activities. It provides a protective overshot range and is periodically used for midshipmen training. Greenbury Point is managed to restore and enhance its natural resources as required by the Sikes Act.

PERMITTED USERS

Nature Center: The Greenbury Point **Nature Center** is open to the general public on Thursdays , 11 am to 3 pm, unless otherwise posted.

Carr Creek Marina: The **Marina** is for the use of MWR slipholders and guests only.

Possum Point: Possum Point is open to the general public. Fishing allowed with a valid MD State Fishing License.

Greenbury Point Walking Trails: Marked trails are open to the general public from sunrise to sunset, unless otherwise posted.

Greenbury Point Access Roads: Gravel Access Roads are open to the general public when advertised as open. **Access to these roads is PROHIBITED when the range is in use and security gates are closed. IF GATES ARE CLOSED, DO NOT ENTER!**

RULES AND REGULATIONS

- Follow all posted rules, directions and as given by security personnel.
- Park in designated spaces only. **DO NOT PARK ON GRASS!**
- Pedestrian and bicycle travel is allowed on designated Walking Trails and Access Roads (when advertised as open) only.
- All dogs MUST be leashed at ALL times. Leash should not be more than 10 feet in length and one end should be secured to restrict movement of the animal. Non-compliant dog walkers may be asked to leave.
- Pet owners shall pick up and remove all pet waste.
- Leave wildlife, plants, and artifacts undisturbed so that others may enjoy them.
- Take litter home, or place in trash containers where provided. This includes pet waste.
- Be aware of hazards on the property such as: ticks, stinging insects, poisonous plants, wild animals, and leashed animals.
- Do not dock boats along the shoreline or walk near the shoreline bulkhead.

IV. PROCEDURES FOR ESTABLISHING A NEW OR REVISED CATEGORICAL EXCLUSION

Pursuant to section 1507.3(a) of the CEQ Regulations, Federal agencies are required to consult with the public and with CEQ whenever they amend their NEPA procedures, including when they establish new or revised categorical exclusions. An agency can only adopt new or revised NEPA implementing procedures after the public has had notice and an opportunity to comment, and after CEQ has issued a determination that the procedures are in conformity with NEPA and the CEQ regulations. Accordingly, an agency's process for establishing a new or revised categorical exclusion should include the following steps:

- Draft the proposed categorical exclusion based on the agency's experience and substantiating information;
- Consult with CEQ on the proposed categorical exclusion;
- Consult with other Federal agencies that conduct similar activities to coordinate with their current procedures, especially for programs requesting similar information from members of the public (e.g., applicants);
- Publish a notice of the proposed categorical exclusion in the Federal Register for public review and comment:
- Consider public comments:
- Consult with CEQ on the public comments received and the proposed final categorical exclusion to obtain CEQ's written determination of conformity with NEPA and the CEQ Regulations;
- Publish the final categorical exclusion in the Federal Register;
- File the categorical exclusion with CEQ; and
- Make the categorical exclusion readily available to the public through the agency's web site and/or other means.

A. Consultation with CEO

The CEQ Regulations require agencies to consult with CEQ prior to publishing their proposed NEPA procedures in the *Federal Register* for public comment. Agencies are encouraged to involve CEQ as early as possible in the process and to enlist CEQ's expertise and assistance with interagency coordination to make the process as efficient as possible.²¹

I have the same questions about the construction of the MWR Cottages on Greenbury Point. Was this covered by the same Categorical Exclusion or was there a new one and/or was there an Environmental Impact statement and/or an Environmental Assessment for that work (which is still ongoing)?

- Q. Was there an environmental impact statement done and available for the public to see for the 2019 renovations of the USNA golf course on NSA Annapolis? I believe this was required by the National Environmental Policy Act.
- R. According to our Public Works Dept. (PWD) the project was a renovation to the Greens and Bunkers and received a NEPA Categorical Exclusion, along with other appropriate permits. A NEPA Categorical Exclusion is defined as "a class of actions that a Federal agency has determined, after review by Council on Environmental Quality (CEQ), do not individually or cumulatively have a significant effect on the human environment and for which, therefore, neither an environmental assessment nor an environmental impact statement is normally required. The use of categorical exclusions can reduce paperwork and save time and resources.

- R. I have not been able to confirm that 500 tress were removed. Our PWD combed through documentation and could not find where trees were removed. There have been several projects at the golf course over the last few years and the only project that discussed trees being removed was the Short Game Practice Course project. A building was installed, which required some trees to be removed, but they were mitigated with the replacement of trees.



I have met the nicest people on the trails are Greenbury point and never once have I ran into someone who is shady or made me feel unsafe. Has a fisherman ever left trash, possibly but that is no excuse to close off hiking trails along the water to the entire Anne Arundel county residents and visitors.

So yes, we are upset and there are many national investigative reporters looking into the reasoning behind these decisions. This will be on national news soon and they are talking Netflix series.

The Navy has been a good community partner in Annapolis and we want them to have what they need to be mission ready. GOLF is not mission ready.

It sounds like (b) (6) is not a federal employee but he's incentivized on monetizing Navy assets? He's probably just doing his job and I don't know if he's the problem, but I will say this proposal is a problem.

I believe the Navy will be fair in their decision but that's to be determined. It's up to the Navy now to decide whether or not they want to allow the public to enjoy nature and to fish for their families or if they want to continue to close it off to the public.

I guess time will tell but we are not giving up. The right thing is to conserve this land and provide public access for multiple reasons.

I received two calls yesterday inquiring about the golf course proposal.


First was from State Senator Elfreth's office. Several constituents have asked to meet with her to engage with her on the topic.

Bluf: Since the County sent a letter last week with competing interests to lease Greenbury Point DASN E,I &F stated no requests for sole source negotiations are to be reviewed. As of now the Navy is not moving forward on any lease negotiations for Greenbury Point and the land will remain as it is.

Discussion: Last week Anne Arundel County Executive Steuert Pittman called and informed me the county will release a letter of intent to request sole source negotiations to lease Greenbury Point. The county's idea is to build public walking trails and water access. Due to this, I was informed by DASN E,I &F's Office to stop all discussions with NAGA and Anne Arundel County regarding Sole source negotiations since there are two entities asking to sole source lease the same property. I am awaiting word back from DASN E, I and F's office or NAVFAC Real Estate on the way ahead. I have briefed (6) (6) head of NAGA, Steuert Pittman, Ann Arundel County Executive, and the Maryland Congressional delegation staff on the above also.

. The installation is now looking ahead to determine how much access we can provide on the roads going around Greenbury Point for public walking. Currently there are 5 trails open for public recreation everyday but the access road access has been limited due to some antenna maintenance and the rifle range Surface danger zone extends over the Greenbury Point. I am working with my staff to determine how much access we can provide around mission and safety requirements.



Dear Mr (b) (6)

My family and I are writing to express our deep concern about the proposed development at Greenbury Point in Annapolis and to urge you to reconsider the plans for this precious land. Greenbury Point is not only a valuable natural resource, but also an important part of our local community, and its destruction would have serious consequences for both the environment and the people who live here.

We have a special history with Nature Center at Greenbury Point and want to protect the work that has been done on its behalf by sister, and aunt, a dedicated environmenta atural resources program manager hired and tasked by the Navy to create the conservation plan for the area. During her tenure, Tina planted 35 acres of grassland meadows and partnered with the Maryland DNR to help restore 33 acres of wetland habitat assisting in a Diamondback Terrapins restoration effort at the nature center to release them back into the wild, not to mention all the exhibits she created for the nature center regularly hosting local schools and scout groups.

work was instrumental in preserving the natural beauty of this area, and her vision rought to life by many people who provided their expertise and their sweat equity. This vision has also been supported, in varying degrees, for three decades by her successors and by the Navy Facilities Norfolk which oversees this property and has followed a commendable stewardship program for environmentally sensitive lands along the Chesapeake. The Navy and the State of Maryland several years ago planted hundreds of trees along the point to continue these conservation efforts at the taxpayer's expense. A golf course seems to be not only a step backward but ineffectual to those efforts.

Furthermore, the proposed golf course development would require extensive maintenance and water with chemicals, pesticides, and fertilizers, which could have serious environmental consequences for the tidal and non-tidal wetlands which surround the point. This is simply not compatible with the delicate balance that exists at Greenbury

Point, which serves as a breeding ground for the endangered Northern Bobwhite Quail, as well as a home for a multitude of birds, reptiles, amphibians, butterflies, and insects.

Most importantly, Greenbury Point has long been used by community members, and visitors, who value its pristine natural environment and the recreational opportunities it provides. Any development would destroy the peace and solitude that these individuals have come to cherish and would deprive future generations of the chance to enjoy this remarkable space.

Another troubling concern is the current INRMP, which was allowed to lapse by the agencies that had its oversite including the NSA Annapolis, the U.S. Fish and Wildlife Service, the Maryland Department of Natural Resources, and the Naval Facilities Engineering Command Washington, all who mutually agreed to "conserve, protect and manage fish and wildlife resources". It seems the lapse prompted parties to assume that the protection of Greenbury Point as a conversation area was no longer valid.

Finally, we would like to emphasize that green open space is necessary for the prevention and reversal of climate change. Trees, plants, and natural areas absorb carbon dioxide and other greenhouse gases from the atmosphere, helping to mitigate the effects of climate change. Greenbury Point is an essential part of this effort, and we must do everything we can to preserve it. Congress in 1998 in an amended version of the Defense Appropriations Bill stated "The undeveloped sections of Greenbury Point will remain in their natural state." The provision was to halt any future development of the 221-acre waterfront wildlife refuge. If the environmental commitments and mandates are now disregarded, were they ever seriously implemented?

In light of all these important concerns, We urge you to reconsider any plans for development at Greenbury Point and to instead focus on preserving this unique natural resource for future generations. Thank you for your time and attention to this important issue.

Below I have answered the questions with information we have now. I also met with (6) (6) and the USNA PAO today to develop a PA holding statement for PA inquiries. Ed and the USNA PAO are releasing that holding statement today to answer the inquiries we have received so far.

Who's land is it (Greenbury Point)

Greenbury Point is a part of Naval Support Activity (NSA) Annapolis. The land was formerly to support a communication station and for the antennas supporting Very Low Frequency (VLF) transmissions.

What it's used for now

The land has since been converted to green space and supports MWR facilities. There is an MWR Marina and MWR Cottagesunder construction (planned over the last 10 years) and expected to open at the end of this year. Land on Greenbury Point has also been used for environmental mitigations resulting from construction in other areas of the installation. This mitigations consists mostly of planting trees.


***There are no installation plans in development for a hotel or lodging to support a golf course. I cannot speak for Annapolis Properties (owners of the Former David Taylor Research Center) plans. But my observations of this area show no construction ongoing.

Who is requesting the golf course be built (Navy or outside sources)

The Naval Academy Golf Association (NAGA), a Non-federal Entity, is requesting sole source authority to lease Greenbury Point for the construction of a second golf course. The project is at the first stage of receiving approval to allow them to move forward with environmental and planning efforts. The installation has forwarded the request to NAVFAC Real Estate for review. Final approval is at the EI&E level.

----There is also interest in this project from the several members of the Retired Flag Wardroom

Intent for the land use (not just a golf course, but also walking trails and conservation areas)



What will the community impacts be.

Currently there is significant community encroachment using the utility roads as walking trails, fishing along the shorelines, and several photographers who take pictures of birds from the Greenbury Point area. During construction there would be impacts to the community's ability to access the area. Also after the construction, if and how, NAGA incorporates trails and access to the shoreline will impact how the community can use the area.

Is this a "done deal" or will there be community meetings/discussions on this?

This is a long way from becoming a done deal and will take several years to complete. The proposed lease must first be approved at EI&E. If it is approved this will force a NEPA action leading to an EA for the construction of the Golf Course.

During this EA there is required public comment. This will also trigger a need to develop a new Installation Environmental Development Plan since the environmental mitigation areas on Greenbury Point will be changed. This will cause a second NEPA action and EA which will require more public comment on the Environmental Development Plan. Finally a golf course will require several federal and state permits. These permitting actions will bring in separate regulatory scrutiny of the planned development.

I am providing a lot of information primarily more as background information in response to Ms.

(b) (6) email as well as the follow-on from (b) (6) /DASN EM&R. Most of this information is intended to be kept "on-hand" should any parties within DOD/Navy request it.

Separately below I have provided a draft response to Ms. (b) (6) opening paragraph. I trust that you and the PAO team can and will respond to the rest of her statements, as appropriate.

BACKGROUND

The NSA Annapolis INRMP was developed to support the installation mission by way of compliance with all applicable natural resources laws. This includes compliance with the Sikes Act Improvement Act (SAIA) of 1997, which involved consultation and cooperation with the U.S. Fish and Wildlife Service (USFWS) and the Maryland Department of Natural Resources (MDNR) regarding conservation, protection, and management of fish and wildlife resources, and ongoing annual review of INRMP implementation. The Sikes Act also states that installations, via the INRMP, should provide public access for natural resources uses to the extent it is appropriate and consistent with the installation mission, and that implementation of an INRMP shall not cause any net loss in the capability of the installation to support the military mission.

The objectives and goals of the INRMP focus on responsible stewardship of the natural resources on the installation, with the flexibility necessary to maintain the installation's ability to enable the education, training, and development of midshipmen morally, mentally, and physically. Per the NSA Annapolis INRMP sections regarding Outdoor Recreation, our goal is to provide outdoor recreational opportunities for station personnel, their dependents, and the general public to the maximum extent possible within the constraints of the installation mission and capability of the natural resources. NSA Annapolis restricts access to portions of Greenbury Point when mission activities are taking place that can endanger installation personnel or the public, or is required by mission parameters. It is important to note that several of the outdoor recreation areas, viewpoints, and designated trails, including the Bobwhite Circuit Trail, the Timberdoodle Trail, and the Pipsissewa Trail, remain accessible to the public during the vast majority of mission-related closures at Greenbury Point.



HISTORY

The Susquehannock Indians inhabited Greenbury Point at the time of European settlement in 1649. By 1676, however, there was virtually no native presence in the area.

The first European settlers on Greenbury Point were given a grant by the proprietary ruler of Maryland: Cecil Calvert, the second Lord Baltimore. The settlement was called Towne Neck and after 1676 the land was principally farmland.

Ralph Williams owned most of Greenbury Point from 1661 until his death in 1673. His heirs owned it until 1685 when it was sold to Nicholas Greenberry, the new namesake of the area.

Most of Greenbury point was purchased by the Naval Academy in

1910 in order to establish a dairy farm. The intent was to provide safe dairy products to midshipmen in a time when tuberculosis was common. In 1914 the dairy farm moved to Gambrills, MD.



Beginning in 1911, the property was used for experimental studies in naval air warfare. From 1918 until 1996 the area was used for communications research and to transmit strategic information to the U.S. fleet in the Atlantic Ocean and the Mediterranean Sea.

All but three of the radio communication towers were dismantled in 1999 and the peninsula is now a managed conservation area. A nature center has been established to promote education, stewardship, and enjoyment of Greenbury Point's rich cultural and natural heritages.

RULES AND REGULATIONS

- Pedestrian and bicycle travel is allowed on designated Walking Trails and the East and West Access Roads, unless otherwise posted.
- All dogs MUST be leashed at ALL times. Leash should not be more than 10 feet in length and one end should be secured to restrict movement of the animal. Non-compliant dog walkers may be asked to leave.



Exclusive: Naval Academy Athletic Association ready to submit its proposal for Greenbury Point Chet Gladchuk asked to borrow a pen, flipped over a paper placemat and drew a long line.

Sitting at an Annapolis diner over a cup of coffee, the longtime Naval Academy athletic director wanted to illustrate just how small Greenbury Point compared to the entire Chesapeake Bay.

He drew a line representing the California coastline, 840 miles. A golf course there – like the one he proposed in February for the Navy conservation area – would be tiny.

"How long is the Chesapeake Bay coastline?" he asked and answered, "11,684 miles."

He called the environmental impact of a golf course at Greenbury Point on the bay's health almost infinitesimal.

"Do you think this molecule is going to kill the bay?"

Yet Gladchuk said he understands the concerns expressed by members of Congress, environmentalists and community members about building a second golf course at Greenbury Point. The proposal he is developing as head of the Naval Academy Athletic Association will be environmentally responsible, he said, enhance recreational resources for the public and help make Naval Academy golf and cross-country teams more competitive.

One day after the Navy said it would pause consideration of the proposal now that a competing one has emerged from Anne Arundel County – without the golf course. Gladchuk said the process is far from over. It's only just begun.

"There are a number of people who see it as a place where you can make something special," Gladchuk said. "It's a wonderful opportunity to take all its current uses and improve them."

In an exclusive interview with Meanwhile, in Annapolis, Gladchuk said the association plans to submit his full proposal in the immediate future – "soon" – and expects the Navy will give it full consideration.

"There isn't a concern that's been expressed or a consideration we have heard that we aren't addressing,"

Gladchuk said.

The Tuesday morning interview followed a few frenetic weeks surrounding the future of Greenbury Point. A 240-acre Navy nature conservancy, it juts into the bay between the Severn River and Whitehall Bay and is part of an installation that supports the academy.

Since the Navy bought the land 112 years ago, it has been a dairy farm, an experimental aviation facility and a transmitter station reaching ships and boats in the Atlantic and Mediterranean.

At the end of the 20th century, the Navy took down all but three of its radio towers and listed hundreds of

acres as a conservation area. It remains part of the Naval Support Activity Annapolis, along with workshops, garages and offices, a commissary and an elementary school, recreational facilities and housing.

In February, <u>Gladchuk wrote to Navy Secretary Carlos Del Toro</u> and proposed adding an 18-hole golf course next to the one operated by the Naval Academy Golf Association for decades. He asked the Navy to consider the proposal as a "sole source" lease, according to a copy of his letter obtained by Meanwhile, in Annapolis. That would mean going forward without a competitive process.

"The benefits of our partnership that that NAGA has provided to the Navy and to the Naval Academy for over 50 years have demonstrated that it is in the best interests of the government to enter into a sole source lease for this project," he wrote. "This will permit us to start the lead negotiations to start the design process with a clear way forward and a more compressed timeline."

When the proposal became public in May, there was a vocal response from environmental groups concerned about the impact of a private course – visions of chemical-controlled greenways fenced off from the public – in place of a wild, overgrown network of trails and shoreline there now.

"Save Greenbury Point" Facebook pages popped up; environmental groups lamented the potential loss of habitat for birds, butterflies and other species. Members of Congress asked for details, and County Executive Steuart Pittman jokingly said he'd tie himself to a tree there as a gesture of support.

Then on Wednesday, Pittman wrote to the captain in charge of the Annapolis Navy station and offered to take over management of Greenbury Point as a county park. The county would, he wrote, improve and expand public recreational uses, maintain academy training programs and, not inconsequentially, eliminate a headache for the Navy.

"The Navy is in the business of defense, not public access," Pittman said on Friday.

Monday, a Navy spokesperson said the arrival of a second proposal meant it would not consider a Greenbury Point lease without a competitive process. That halted a process that began in May, when a lead planner was assigned to the project and given a list of steps necessary to move forward, according to internal email obtained by Meanwhile, in Annapolis.

"As of now, the Navy is not considering any sole source lease proposals for Greenbury Point," Ed Zeigler, director of public affairs for Naval District Washington, wrote on Monday.

Zeigler's said the Navy is considering what to do with the land, a decision met with relief in the community. It also is in the midst of updating its management plan for the area.

"I fully respect the decision of the Navy at this time and know it comes as a relief to surrounding communities that the current use of the land will continue until the Navy deems future changes necessary to fulfill their mission while keeping the channels of communication open with local elected officials," County Councilwoman Amanda Feidler, who represents the area, wrote in an email.

Gladchuk said the Navy statement doesn't mean consideration of the athletic association proposal has ended.

"Who said that?" he asked. "Who made the decision that it's over?"

Instead, he said consideration of his proposal wouldn't begin until it is submitted. He expected it to be turned in quickly and predicted the details would become public shortly afterward. He said the Navy would decide on the proposal in its own time.

Gladchuk applauded Pittman's competing proposal but said everything in the one-page letter will be found

in the athletic association proposal – environmental clean-up, better public facilities and smarter access. The current rules shut down Greenbury Point without notice, usually because of activity at the rifle range or other training programs.

A spokesperson for the county said Tuesday it was waiting for a response to its initial letter of interest that would hopefully explain how to submit a fuller proposal.

Gladchuk said his proposal has two key advantages over the county's pitch: benefit to the academy's core mission – excellent facilities and competitive teams help develop mids "morally, mentally and physically" – and private funding over taxpayer dollars.

The current golf course and trails, he said, limit how well the academy can compete in two sports, golf and cross country track.

"We can't host national events," Gladchuk said. "We can't host a regional golf tournament ... or cross-country meets."

Once the Navy begins work on evaluating the athletic association proposal, plenty of people will be watching – including members of Congress.

In <u>a letter sent Monday to Secretary Del Toro</u>, U.S. Sens. Ben Cardin and Chris Van Hollen, along with U.S. Reps. John Sarbanes and Dutch Ruppersberger laid out "three baseline requirements" they have for consideration of any proposal.

Those are zero environmental impact on waters bordering Greenbury Point, public access at current or enhanced levels and compliance with wetlands protection under Maryland's Chesapeake Bay Critical Area Act.

"We urge you to carefully consider these requirements should you evaluate various proposals to redevelop or change Greenbury Point," the members of Congress wrote.

As president and CEO of the Chesapeake Conservancy, Joel Dunn has been a leading critic of Gladchuk's proposal,. He released a statement Tuesday saying he didn't see how a private golf course could comply with these requirements.

"Chesapeake Conservancy will advocate for the passage of federal legislation to protect this conservation area permanently and if necessary, to transfer management to an agency that will take care of this precious wildlife habitat," he said.

Gladchuk said his proposal will reflect congressional concerns about the environment, recreation, and public access. He hasn't been surprised by the public interest.

"It's exactly what you'd expect...," he said. "But we're not going to build a shopping mall... They all speak to the vision of maintaining an environmentally responsible Greenbury Point. We get it." He said he hopes to work with environmental advocates and community members passionate about the land if the Navy decides to move forward with the proposal.

Eighteen more holes would make more golf available to military personnel, academy alumni and retirees who use the current course. But Gladchuk said that is a lesser priority than reaching a higher level of excellence in academy athletic facilities.

Enhanced golf and cross-country courses at Greenbury Point would be the latest improvement of athletic facilities during Gladhuk's 21-year tenure as athletic director. Technically, he is an employee of the Naval Academy Athletic Association – a nonprofit that supports academy athletic programs.

The association has funded millions of dollars worth of improvements to the academy's football and baseball stadiums, a new field house, renovated the existing golf course, added a brigade sports complex that hosts the hockey teams, and built a multi-purpose center that showcases academy athletic achievements.

Gladchuk said he's proud of those projects and others but keeps his primary focus on creating a winning season for the academy's most visible sport, football.

He sees Greenbury Point as an opportunity to add to the legacy of his tenure, even if it reaches completion long after he has retired.

"I've done this for my entire career," Gladchuk said. "Do you think I would jeopardize that for a few more tee times?"







GRANTOR shall provide notification to the GRANTEE prior to taking any of these actions. This provision will survive the expiration or termination of this easement, and the GRANTEE's obligations hereunder will apply whenever the GOVERNMENT incurs costs or liabilities resulting from the acts or omission of the GRANTEE, its agents, or contractors.

- 12. To the extent that work is performed by persons or organizations on behalf of the GRANTEE, the GRANTEE shall require such persons or organizations to:
- a. Procure public and employee liability insurance from responsible insurance companies authorized to do business in the State of Maryland with a minimum limitation of \$500,000 per person for any one claim and an aggregate limit of not less than \$1 million for any number of claims arising from any one incident, and insurance to cover all damages arising out of injury to or destruction of property with a minimum limitation of \$250,000 for any one claim and an aggregate limit of not less than \$500,000 for two or more incidents. The United States of America shall be named as an additional insured on all such policies. All such policies shall specify that the insured shall have no right of subrogation against the United States for payments of any premiums or deductibles thereunder and such insurance policies shall be assumed by, be for the account of, and be at the insurer's sole risk;
- b. Pay the United States the full value of all damages to the Premises or other property of the United States caused by the GRANTEE or by his employees or his contractors and their employees;
- c. Indemnify, save, hold harmless, and defend the United States against all fines, claims, damages, losses, judgments, and expenses arising out of or from any omission or activity in connection with activities under this grant of easement; and
- d. Include as a specific term of all such policies the provision that they shall not be canceled or materially changed without at least ten (10) days written notice being given to the GRANTEE.
- e. Notwithstanding any provision to the contrary in this paragraph, GRANTEE may be self-insured under the provisions of its self-insurance program authorized by the Anne Arundel County Code, Article 2, Title 5. In the event the foregoing provision is repealed or is found to be invalid, GRANTEE shall provide the insurance required by this paragraph.
- 13. This easement is granted subject to any and all reservations, recorded and unrecorded, for pipelines, drainage, sewer mains and lines, and public utilities, if any.

- 14. In the event of damage, including damage by contamination, to any Government property by the GRANTEE, its successors and assigns, its officers, agents, servants, employees, subtenants, and/or invitees the GRANTEE, at the election of the Government, shall promptly repair, replace, or make monetary compensation for the repair or replacement of such property to the reasonable satisfaction of the Government. Prior to the execution of this easement, the GRANTEE shall provide evidence of compliance with all local, state, and federal environmental laws and regulations. In the event of any contaminants, hazardous wastes, or hazardous substances, the GRANTEE shall obtain insurance or post a bond in an amount sufficient to cover possible clean-up costs. The amount shall be determined by the Commanding Officer, Engineering Field Activity Chesapeake.
- 15. The reporting, notification, containment and cleanup of spills resulting from the use of the property are the responsibility of the GRANTEE.
- 16. In accordance with 10 U.S.C. § 2692, the GRANTEE will not store or dispose of any toxic or hazardous materials on the Premises. For the purposes of this provision, the terms "storage" and "toxic or hazardous materials" are defined as provided in 48 CFR Subpart 252.223-7006.
- 17. The GRANTEE shall be responsible for making application for and obtaining all necessary permits and approvals, prior to initiating any construction activity, with regard to local, state, or federal environmental standards or wetlands disturbance on Government landholdings described in this easement and will be responsible for mitigating environmental issues encountered as a result of the execution of this easement.
- 18. During the term of this easement, If the GRANTEE becomes aware that a release of toxic or hazardous materials has occurred because of the acts or omissions of the GRANTEE or its agents or contractors and such release has resulted in contamination of the Premises or adjacent Station land, GRANTEE will provide oral notice to the Government within 24 hours of becoming aware of such contamination, providing all relevant facts and circumstances. The Government may request from the GRANTEE a more detailed written description of these facts and circumstances within a time period specified by the Government. GRANTEE shall promptly take all actions, at its sole expense, as are necessary to comply with all applicable environmental laws relating to such release, including reporting the occurrence to the appropriate Federal, State, or local regulatory authority or taking required remedial action, related to addressing the contamination and to minimize the impacts of such release. GRANTEE shall provide all information requested by the Government regarding such actions.
- 19. During the term of this easement, GRANTEE shall ensure that all activities conducted by it or its agents or contractors on the Premises or other Station land are carried out in compliance with applicable environmental laws. GRANTEE shall provide oral notice to the Government within 24 hours of receiving any complaint, order, directive, claim, citation, or notice by any governmental authority or any other person or entity with respect to a violation of applicable environmental laws resulting from the acts or omissions of GRANTEE or its agents or contractors on the Premises or other Station land. GRANTEE shall promptly take all actions, at its sole expense, as are necessary to comply with all applicable environmental laws as directed by any Federal, State, or local regulatory authority. The Government may request a more detailed written description of the events or circumstances leading to this event within a time specified by the Government. Without limitation of the foregoing, in response to the acts or omissions of the GRANTEE or its agents or contractors on the Premises or on other Station land, the Government may, but will not be obligated to take any remedial action as it deems necessary or advisable to address any Contamination of the Premises or other Station land by toxic or hazardous materials or to ensure compliance with applicable environmental laws.

- 20. At any time, the Government or its representatives may conduct inspections on the Premises to assess whether the operations of the GRANTEE or its agents or contractors are in compliance with applicable environmental laws. To assist in this evaluation, the GRANTEE shall provide to the Government or the Government's representative, any and all books, records, or documents in their possession, or in the possession of its agents or contractors, related to the activities or operations on the Premises, which the Government or its representatives may examine, copy, or make extracts therefrom.
- 21. As the Government deems appropriate, GRANTEE may from time to time be required to promptly conduct such tests and procedures for the purpose of assessing whether the PREMISES are in compliance with Applicable Environmental Laws and having the PREMISES certified to the GOVERNMENT as being in compliance. Such tests and procedures shall be conducted by recognized professionals to be approved by the GOVERNMENT, and conducted in a manner that is satisfactory to the GOVERNMENT. When requesting such tests and procedures, the GOVERNMENT shall work with GRANTEE to establish accepted timeframes, appropriate parties to perform the required activities, and schedules for performance. If an agreement cannot be reached regarding any of the foregoing, the GOVERNMENT or its representatives may undertake such tests and procedures.
- 22. For purposes of this provision, the terms used above are defined as follows:

"Toxic or Hazardous Materials" means any hazardous, harmful, odorous, radioactive, toxic or dangerous waste, substance or material, including, without limitation, asbestos, polychlorinated biphenyls ("PCBs") and petroleum products, and any hazardous or toxic substance, material or waste, or any pollutant or contaminant defined as such in, or for the purposes of, any environmental laws as are now or in the future may be in effect. GRANTEE's obligation under this provision shall extend to any and all such Toxic or Hazardous Materials, whether or not such substance was defined, recognized, known, or suspected of being hazardous, toxic, dangerous, or wasteful at the time of any act or omission giving rise to GRANTEE's obligation.

"Contamination" means a level of Toxic or Hazardous Materials in the air, in or on soil, in the surface water, or in the groundwater that exceeds levels allowed by Applicable Environmental Laws.

"Applicable Environmental Laws" means any Federal, State, or local statute, law, ordinance, rule, regulation, or order (whether voluntary or not) that govern the activities or operations of the PREMISES, or the persons carrying out those activities or operations, relating to the environment, natural resources, or human health and safety, including without limitation the Comprehensive Environmental Response, Compensation, and Liability Act (42 U.S.C. § 9601 et seq.), the Hazardous Material Transportation Act (49 U.S.C. § 1801 et seq.), the Resource Conservation and Recovery Act (42 U.S.C. 6901 et seq.), the Federal Water Pollution Control Act (33 U.S.C. § 1251 et seq.), the Clean Air Act (42 U.S.C.

§ 7401 et seq.), the Toxic Substances Control Act (15 U.S.C. § 2601 et seq.), and the Occupational Safety and Health Act (29 U.S.C. § 651 et seq.), as such laws have been amended or supplemented now or in the future.

"Release" means any release, spill, emission, leaking, pumping, injection, deposit, disposal, leaching, or migration into the environment, whether accidental or otherwise, resulting from the act or omissions of GRANTEE, its contractors, or by natural conditions.

"Remedial Action" means any investigation or monitoring of the condition of the PREMISES or any cleanup, remedial, removal, or restoration work required or performed on the PREMISES because of the presence, suspected presence, release, or suspected release of Toxic or Hazardous Materials.

- 23. The GRANTEE agrees to halt all operation, maintenance, and repair and notify the Department of the Navy immediately if any cultural resources are observed at any time during the operation, maintenance, and repair of the three towers. Cultural resources is a generic term commonly used to include buildings, structures, districts, archeological sites, historic landscapes, Traditional Cultural Places, Indian sacred sites, and objects of significance in history, architecture, archeology, engineering or culture. The term also includes associated documents and records.
- 24. Access to the towers is within an area designated for active firing. GRANTEE and its successors, assigns, and contractors shall coordinate, in advance, all visits to the three towers with the Naval Academy Range Control Range Manager at (410) 293-4338. Failure to coordinate and schedule visits may subject personnel to harmful or life threatening conditions.
- 25. It is expressly understood and agreed that the granting of this easement for access does not constitute the Government's authorization for the construction of any ancillary facilities to support the operation, maintenance, and repair of the three towers. However, such authorization shall not be unreasonably withheld. Prior to any construction, GRANTEE shall request authorization and submit plans for review and approval by the Superintendent.
- 26. If the GRANTEE assigns or sublets all or part of the three towers, each assignee or subletee shall be bound by the terms and conditions of this Grant of Easement.
- 27. The lands upon which the towers are situated have been identified and designated as Installation Restoration sites for which the Government will conduct removal actions. A Finding of Suitability to Transfer (FOST) which is attached hereto and made a part hereof, provides notification to the GRANTEE of the current environmental condition of the property along with any special restrictions and conditions for the use of those areas.

KNOW ALL MEN BY THESE PRESENTS: That the UNITED STATES OF AMERICA, Seller, acting by and through the Department of the Navy, Engineering Field Activity Chesapeake in consideration of mutual benefits and as approved by Section 2855 of the FY 2000 National Defense Authorization Act hereby sells, assigns, transfers, and sets over unto the said personal property herein described all of its right, title, and interest in and to ANNE ARUNDEL COUNTY, MARYLAND, Buyer. Said personal property being described as follows:

Three (3) radio transmitter towers located at the former Naval Radio Transmitter Facility, most commonly referred to as "Greenbury Point", exclusive of the underlying land, as delineated on the attached map identified as Exhibit "A" which is attached hereto and made a part hereof.

Paint samples were collected from each of the towers in 1998 by an analytical subcontractor for the Department of the Navy. These samples were analyzed for lead and PCB's. Lead was detected throughout the paint chip samples; however, no PCB's were detected. A copy of the scope of work for this effort and a summary of the results are attached hereto and made a part hereof as Exhibit "B". Any abatement, removal, or disposal of the lead shall be the obligation of the Buyer.

Osprey and other raptors have been observed roosting and nesting in the towers and they are protected under the Migratory Bird Treaty Act. Under the Migratory Bird Treaty Act, no nest may be taken that contains eggs or young or that is in the process of being refurbished by adult birds for nesting purposes. The Buyer shall be responsible for complying with the Migratory Bird Treaty Act and contacting the Fish and Wildlife Agency to obtain instructions that will prevent harm and/or harassment towards the Osprev/Raptors.

By acceptance of this Bill of Sale by Buyer it is mutually agreed and understood that:

At any time should Buyer determine that any one or all of the towers are no longer needed or required, Buyer, at its own expense, shall promptly have the tower(s) removed from Government property. Such removal shall be coordinated with and performed in a manner satisfactory to the Superintendent of the United States Naval Academy and in accordance with all applicable laws and regulations.

Buyer shall be responsible for the operation, maintenance, and protection of the towers. Buyer understands that the towers are offered and conveyed on an "as is", "where is" basis, without representation or warranty on the part of the Seller as to their suitability for any purpose. Seller is under no obligation to make any repair, alteration, or addition to the towers or to perform any act of maintenance or upkeep thereto.

Buyer shall contract and pay for all services and utilities associated with its ownership of the tower(s). All meterable utilities shall be obtained and paid for by Buyer, which will bear the responsibility and cost of meter installation, maintenance, replacement, and removal inclusive of distribution lines, ductbanks, and associated manholes. The Seller shall not be under any obligation to provide service or utilities. Submetering, at the option of the Seller, is an acceptable alternative if utility payments are made directly to a designated office or service provider.

As consideration for the conveyance of the towers, Buyer shall provide Seller with approximately one platform of space for the placement of one or more antennas and adequate space within equipment shelters that may be constructed in the future to support the operation and/or placement of the antennas.

Buyer acknowledges that the tower(s) are located on Government owned land and that a grant of easement for access is required and will be executed separately from this Bill of Sale. A land survey, along with a written metes and bounds description, are required prior to the granting of the easement. Buyer shall be responsible for obtaining the survey without any expense to Seller. The survey shall be conducted by a licensed Land Surveyor for the State of Maryland.







We received another FOIA request related to Greenbury Point. This one from (b) (6) the Washington Post (he appears to be a DMV-focused reporter rather than national). Request is similar, but not identical, to past requests:

"Any and all documents concerning a proposal to build a golf course on the Greenbury Point peninsula located across from the United States Naval Academy between the Severn River and the Chesapeake Bay in Annapolis, Maryland.

More specifically, we would like to obtain copies of emails, letters, memoranda, maps, plans, images or any other documentation related to a proposal advanced by (b) (6) who is USNA athletics director and president of the Naval Academy Golf Association, and perhaps others to build a second golf course.

"I would also be grateful if the Navy would provide documents responsive to similar FOIA requests regarding Greenbury Point and its conservation area and proposed golf course."

Keeping in mind that you and your team have already conducted a search regarding Greenbury Point, I request that you provide me with any *additional* records which have been generated since you completed your last search. I also ask that you and your team review your inbox/sent items for "any and all" emails related to Greenbury Point and the golf course proposal. Any person at NSAA who may reasonably be expected to have e-mails regarding the Greenbury Point golf course proposal should be asked to conduct a search of their inbox/sent items.

I respectfully request a response by 30 September.

To satisfy the second portion of Mr. (b) (6) request, I intend to provide him an interim release consisting of previous FOIA responses on the topic (i.e., all the redacted files that were previously released).
